All districts (ISDs, LEAs and PSAs) have until **December 15, 2013** to complete their data in MTRAx in order to be eligible to participate in year two of the TRIG grant. 2013-14 TRIG RFP District Participation Requirement #4 FAQ

1. Can my district participate in multiple authorized pilot and/or field test opportunities to satisfy requirement #4?

Yes. Any combination of the authorized opportunities may be used to satisfy requirement #4. For example, a 5,500 student district might choose to satisfy the requirement using a combination of the Smarter Balanced Field Test, Michigan Interim Assessment Pilot, and MI-Access FI Pilot as follows:

Smarter Balanced Field Tests Administered

4 th grade ELA	= 400
7 th grade math	= 400

Michigan Interim Assessment Pilot Tests Administered

Kindergarten ELA	= 25
Kindergarten math	= 25
2 nd grade ELA	= 50
2 nd grade math	= 50
Biology	= 50
Chemistry	= 50

MI-Access FI Pilot Tests Administered

5 th grade social studies	= 20
8 th grade social studies	= 20
11 th grade social studies	= 20

Total Pilot and/or Field Tests Administered = 1,110 (meets requirement)

Number of Students (FTE)= 5,50020% of the FTE pupil count:= 1,100

2. My school administered the science or social studies MEAP online this fall. Does that count toward satisfying requirement #4?

No. The MEAP online science and social studies were operational tests, not pilots, and therefore do not count toward satisfying requirement #4.

3. Will MDE expand the list of authorized assessments that count toward satisfying requirement #4?

No. The main objective of this requirement is to ensure adequate participation in the pilot and field tests listed below. Without adequate participation, these assessments will not be ready for operation in 2015. The secondary objectives of this requirement are to provide schools with an opportunity to test their technology configuration and to provide students with online testing experiences in a low-stakes environment.

Completion of Year Two Application Process

The deadline for Year Two District Participation in TRIG is right around the corner. To comply, follow these simple steps:

1. Have you completed the MTRAx survey? The deadline is December 15, 2013.

A list of the districts that have completed the MTRAx survey will be included as an attachment every Wednesday along with the Weekly Update and posted as <u>MTRAx List</u>. The list will be current as of the prior Monday.

2. Have you completed the MEGS+ Application process? The deadline is December 20, 2013.

A list of districts that have completes the MEGS+ application process can be found at <u>MEGS+ List</u>. This list will be updated every Monday and Thursday.

Once you have completed both of these steps, you are all set for now. Your TRIG participation payment of \$10/FTE based on the Fall Blended Count should be included in the January SAMS payment.

Requirement #4 Definition from RFP

4. The district agrees to satisfactorily participate in one or more of the State of Michigan authorized online pilot and/or field test opportunities. To satisfy this requirement, the total number of online pilot and/or field tests administered in the district during the 2013-14 school year, must equate to at least 20% of your district's full-time equivalency (FTE) pupil count from the Fall 2013 Michigan Student Data System (MSDS) Collection. Please see participation examples below.

This requirement includes necessary activities related to online testing such as installing software, attending training, and performing online test preparation procedures. It is understood that the software will not negatively interfere with the district's normal operations. The grant will not require the installation of software under these participation requirements after June 30, 2014.

Example #1: If a charter school with 150 student FTEs administers the science and social studies interim pilot assessments to 15 students in the fourth grade, that equates to 30 tests administered and therefore satisfies this participation requirement.

Example #2: If a K-12 school district with 1,700 student FTEs administers the ELA and math interim pilot assessments to 180 students in grades K through 2, that equates to 360 tests administered and therefore satisfies this participation requirement.

Example #3: If a K-12 school district with 5,000 student FTEs administers the US history, world history, biology, and chemistry interim assessments to 250 students (each), that equates to 1,000 tests administered and therefore satisfies this participation requirement.
